CONSIGNMENT POLICIES

- Upscale Resale Gallery accepts consignment items based on condition, demand and style. Consigned items must be in good condition; free of scratches, tears, stains, broken parts, free of odors, smoke, and pet hairs. In the event we need to clean or repair an item to place on the showroom floor, the charge will be subtracted from the consigners check upon the sale of the item. Upscale Resale Gallery may give estimates of value from pictures and descriptions; however, final pricing occurs only after an item is inspected at the store. Upscale Resale Gallery reserves the right to refuse any consignment item for any reason.
- Consignor is the legal owner of the item until the item is sold or otherwise disposed of as provided herein. Consignor holds Upscale Resale Gallery harmless for any damage, vandalism, theft, breakage or other loss from any claim of injury or damage resulting from the sale, storage or use of consigned items.
- Upscale Resale Gallery reserves the right to accept any reasonable offer, discount any item and run promotions or sales without notice to Consignor. Consigned items are on a mark-down schedule of 10% after thirty (30) days and an additional 10% after sixty (60) days. Upscale Resale Gallery makes no guarantee that an item will sell.
- Consignor will receive 50% of the **actual** selling price of a consigned item. Payment to Consignor will be paid on the 15th day of the month following the month of sale. Consignor is responsible for picking up the check in the store. If you would like it mailed, there will be a \$5.00 service charge.
- Contract period is ninety (90) days. Upscale Resale Gallery may terminate this contract at any time and require the Consignor to pick up an unsold item within fourteen (14) days of the request. Any item left unclaimed after the expiration of the contract or earlier termination as provided herein shall be disposed of by Upscale Resale Gallery without any further liability, financial or otherwise, to

consignor and without further notice by Upscale Resale Gallery. Articles listed above are hereby consigned by the undersigned Consignor with Upscale Resale Gallery.

- The consigning fee is \$25.00 per contract. The fee is waived unless the consigner breaks the contract and picks the item up prior to the end of the contract.
- Consignor will receive a discount coupon upon signing this agreement toward a purchase in the store. The coupon will be good through your consignment period.
